
"I wish them well in the future and would like to encourage the local community to offer them all the support they need to make the new site a success."

Council Tax - is it fair?

Brooks has been pleased to present a petition to the House of Commons, on behalf of the IsItFair Campaign, which calls for Council Tax reform.

He said "I had no reservations about supporting this petition, particularly in light of the Government's recent decision to delay a reassessment of Council Tax for the foreseeable future. I think it is long overdue that we should have the 'fair and equitable tax' which the petition calls for."

"Despite the Government's promise to improve the uptake of Council Tax benefits by pensioners, which I welcome, there are still too many people who don't know their entitlements."

Speaking recently at a public meeting against night-flights Brooks told the audience,

"As a father of 5 children I feel very strongly that all our families should have the right to an uninterrupted night's sleep - a night which lasts the traditional eight hours, and not the 6 which the Government now allows us."

Explaining why he voted against the Bill, Brooks said, "I believe very strongly that the legislation infringes our most basic rights. Not the rights cooked up by the Human Rights Act or the European Union, but those to which we have been long accustomed as British citizens."

The real danger which our society faces is from legislation like this which will cheapen the rights of ordinary people. I only hope that our objections, and those which are sure to be made by the House of Lords, will still give the Government pause for thought."

STANDING UP FOR PENSIONERS

In his maiden speech to the House of Commons in June, Brooks Newmark singled out pensioners as those most let down by the Government since 1997.

Two weeks later Brooks questioned Tony Blair about the Government's failure to honour its pledge to end the means-testing of benefits for elderly people.

The Prime Minister's evasive answer confirmed the Government's commitment to a confusing system of extra payments and tax credits. Brooks went on to say "I believe that reform of the state pensions and benefits system is desperately needed. I believe in two priorities for reform.

First and foremost should be to restore the link between average earnings and pensions. The basic state pension is now worth only 15 percent of average earnings, compared with 25 percent in 1980.

The second priority should be an end to means-testing for pensioners. The current system can only lead to uncertainty and unfairness.

We are all indebted to the many voluntary groups which support pensioners within our local community.

I will show similar dedication while I am at Westminster."
